



Entering the Competition

Entries are deemed to be received at the time the completed Competition Entry Form is received by Aurizon via the Queensland Firebirds website – <https://firebirds.net.au/win> (as applicable) and not at the time of submission by the entrant. Entrants are responsible for their own costs associated with entering this competition including accessing the internet to enter via the Queensland Firebirds website.
3. Aurizon is not responsible or liable for any entrant errors, technical malfunction, other issues with communications and/or mail networks, late, lost, incomplete, misdirected, incorrectly submitted, delayed or illegible entries or claims for prizes including when caused by error, omission, tampering, theft or destruction.
4. Aurizon reserves the right, at any time in its sole discretion, to:
 - a. disqualify any entry and/or individual (including the winner) who Aurizon has reason to believe has breached any of these terms and conditions, tampered with the entry or draw process, engaged in any unlawful or other improper misconduct which impacts the fair and proper conduct of the competition or who otherwise acts in a disruptive manner or with behaviour that may diminish or harm Aurizon's reputation or the reputation of any of Aurizon's related bodies corporate, agencies or companies associated with this competition; and
 - b. terminate, modify or suspend this competition, or invalidate entries if Aurizon considers this competition is not capable of running as planned, including due to fraud, tampering, unauthorised intervention, computer viruses/bugs, communication network or postage failures, technical failure or any cause beyond Aurizon's control.
5. Entrants who are under 18 years of age: Entry for Australian residents who reside in Queensland under the age of 18 is subject to consent from the legal guardian or parent of the entrant. To be a valid entry, Aurizon will seek to confirm consent from the legal guardian or parent of the entrant to enter this competition and agreeing to these terms and conditions on behalf of the entrant. Each entrant's consenting parent or legal guardian is responsible for ensuring their familiarity with these terms and conditions. Any Competition Entry Form that does not include contact details for a legal guardian or parent for entrants who are under 18 years of age at the time of entry will be deemed invalid at Aurizon's discretion.

Draw & publishing winning entries

10. This competition is a game of chance. The draw will be conducted at random at the time, on the date and at the location as stated in the Draw Date & Location.
11. Aurizon may draw five additional reserve entries at the draw and record them in case of an ineligible entrant, an invalid Competition Entry Form or an unclaimed prize (**Reserve Winners**).
12. The winner will be notified in accordance with the Winner Notification and Publication section of these conditions.
13. Aurizon recommends that the winner seeks independent financial advice. For GST purposes, where this competition involves supplies being made for non-monetary consideration, entrants will follow the Australian Taxation Office's stated view that where the parties are at arm's length, goods and services exchanged are of equal GST inclusive market values.

Claiming the Prize & unclaimed Prizes

14. To claim the prize, the winner of the prize draw must respond to Aurizon's notification under paragraph 12 by the Prize Claim Date and Time.
15. Aurizon may require the winner (or their legal guardian or parent) to provide proof of identity and residency and a declaration that the winner meets the Eligibility to enter this competition. If the Eligible Entrant is under 18, Aurizon may require their parent or legal guardian to provide relevant bank details.
16. The winning entry will be discarded, and Aurizon will issue the Prize to the first drawn Reserve Winner if:

- a. the prize has not been accepted or claimed in accordance with the Prize Claim Date and Time or if, after making all reasonable attempts, Aurizon cannot contact the drawn winner (or the drawn winner does not contact Aurizon) by the Prize Claim Date and Time; or

20. The entrant agrees that Aurizon and Aurizon's related bodies corporate, agencies and companies associated with this competition will not be liable for, and the entrant releases such entities from any claims for:
- a. any losses (including, without limitation, indirect, special or consequential losses or loss of profits), expenses, damage, personal injury, illness or death which is suffered or sustained (whether or not arising from any person's negligence or otherwise) in connection with this competition or in connection with accepting or using any prize;
 - b. any additional costs incurred by the winner or any other person in connection with the use of a prize, including in relation to travel costs;
 - c. any losses if any part of the prize that includes a ticketed event is cancelled, varied or rescheduled for any reason; and

Promotional activity & intellectual property

24. The winner must, at Aurizon's request, participate in all promotional activity (such as publicity and photography) surrounding the winning of the prize, free of charge, and they consent to Aurizon using their name, other personal information and image in promotional material including on Social Media Platforms.
25. By submitting a Competition Entry Form, the entrant assigns to Aurizon ownership in, and all intellectual property rights (including copyright) in their Competition Entry Form.

Privacy

26. All entries will be the property of Aurizon. By entering this competition, Aurizon and/or its related bodies corporate will collect personal information (including the person's name, age and other details shown on the Competition Entry Form) in order to conduct the competition, promote Aurizon and publicly announce the winner. Entrants' consent to Aurizon using their personal information for these purposes. If Aurizon cannot collect personal information, the individual will be unable to enter the Competition.
